ANTI-SEMITISM AND CRISES

I am sick of anti-Semitism.

This racist mediocrity occurs too often.

Let us consider the part it plays in the present-day crises, of which two are the most remarkable ones: the recent financial crisis and the crisis in physics which took root in the physical science a long time ago. As a matter of fact, these are two global collapses taking place in the fields, which have little in common. At first sight, their causes are also different. Yet, it turned out that the main primary cause is, alas, the same.

Many people take the current financial crisis as bad fate or a natural calamity. It's like - the economy is having diarrhea. However, diarrhea is mostly due to natural causes, whereas the crisis is man-made, and, hence, its causes are simpler to discover. The causes for a crisis are, actually, very few. They just need the right approach. Surely, we might ask economists. This line of action is, however, totally hopeless. It was the economists themselves who fouled the trail and covered up the traces. Only the remnants of the pie that dropped from their fingers are somewhere around.

Another field of interest where a crisis is underway is the exact science of physics. Here the reasons to find more simply. Therefore, this is the crisis we will begin with.

The principal physical statements and definitions are attributed to the Great Aristotle, tutor of the Great Alexander. That was how he called the science dealing with matter and its motion, as distinguished from metaphysics dealing with the spirit world instead of matter. People discovered matter a very long time ago, probably, when it occurred to man why a stone fell to the ground, or why a lion was so afraid of a stick. Besides, survivors were mostly not the ones who showed a charm (or a finger) to wolves, but the ones who tried to hit a wolf with a stone on the head. Simple events made people think that there are material objects with certain properties in the world around them, as well as some laws of motion like those that determined the flight path of a spear. That was the beginning of the science dealing with matter and its motion.

Man certainly has the inner world of his feelings and emotions, but that is something different. Thus, people have known for a long time that matter and our sad or enthusiastic thoughts about it are entirely different things. Besides, they (matter and spiritual and mental phenomena) come from absolutely different dimensions. At a certain time experts in non-matter distinguished themselves from among other people. Their titles varied: oracle, shaman, and what not. Some liked the process – they simply enjoyed ideas and sharing them with others. However, some put their speculations on the market as all sorts of legends. But the market has different laws. As a rule, there are crooks hanging about at virtually any marketplace. That's how patent swindlers appeared among shamans and oracles. It is remarkable that oracles managed to cross-sell allegedly impenetrable armour even to Alexander, a student of Aristotle. Later, during the Battle of the Granicus River, a Persian satrap named Spithridates threw a javelin at him and pierced him including his magic shield and armour. Luckily, the Persian missed, hitting only Alexander's shoulder.

As the example with Alexander's armour shows, ingenious simplicity dominates the swindlers' tactics: they have to combine material and non-material phenomena. That is their strong point of all times. Nothing new has been developed in this field until now.

By the way, production is called material because it deals with matter. Money, on the contrary, especially where relations between financial institutions are concerned, contains conventional elements (see the causes for the mortgage crisis), i.e. it has non-material components. This also provides a vast field of action for crooks.

But let us get back to physics, the science of matter and its motion. There are two absolutely reliable theories: mechanics and electrodynamics, which begin with experiments and are based on experience only. Take a closer look: they are based on a fair distinction between matter and non-matter, according to Aristotle. The situation here is simple: a detective story may begin with fantasy, but not physics – physical laws cannot be learnt without the actual matter. Thus, mechanics and electrodynamics, as physical theories, are based on the philosophy of Aristotle. There is no fraud.

That's where the most interesting thing begins: how did Aristotle's philosophy reach Europe, illiterate at the time? It turns out, it was the literate Averroes and Maimonides who translated, interpreted and passed Aristotle's philosophy on to Europeans. Besides, their translation was strongly adapted. This is confirmed by the accident with Alexander's armour: his tutor's theory must have contained some vague and unconvincing points, since the student was tricked so easily. The theory of Averroes and Maimonides has no unconvincing points. To deceive someone, only a sheer and bold fraud is needed. Without deception there is, naturally, no point in the whole thievish undertaking. Pure mysticism yields no real profit.

You may ask how this is related to the crisis in physics, which was taking place in the 20th century and is taking place now. The idea is very simple: the new so-called physics does not care about matter as Averroes and Maimonides. Now all physical theories start with all sorts of legends, everything in this so-called science is make-believe: the initial, intermediate and final argument stages are sheer make-believe. Everything, from the assumed photons to the assumed Higgs bosons, is pure fiction. It looks like the true physics has been replaced with false physics. Sometimes false physicists hint at the truth of their theories, i.e. associate them with the science of physics, but in fact they just keep speculating on their own ridiculous legends. That's all there is to their deception – it's quite simple. You could say: a fairy-tale is passed as a true story. Unfair commerce is all there is to it. Just a little distraction: "crisis!"

Thus, we saw that the crisis in physics originates from an obvious regress, actual sliding back to the savagery and pre-pagan times, naturally, without the poetry and beauty of the ancient legends. But why? What is the reason for this phenomenon? As there are no other rational explanations, let us look at the cultural peculiarities of the main enlighteners, including their nationality. Averroes (Ibn Rushd) is not only the most notable Arab, but also a chief judge and a mufti, i.e. a protector and promoter of the ideology. And Maimonides (Rabbi Moses ben Maimon) is a Jewish philosopher, a rabbi and codifier of the laws of the Torah – isn't he a Jew? In general, an Arab and a Jew gave our contemporaries their philosophy with their interpretation of Aristotelism. A very wise and constructive doctrine, which has been and must be an integral part of our common culture, especially the science of physics. And suddenly sheer denial and contempt set in among scientists and theoreticians. The Arab and the Jew were much disliked in the 20th century. Rather profoundly disliked. The following issue came up as if by itself: why did this anti-Arab and anti-Jewish vicious doctrine, which has been straightforwardly called with one word – anti-Semitism – for a long time, appear (came up)? Now it does not concern racism, but it is first and foremost as the foundation for a deliberate attack against the man's reason with the subsequent well-organized dissemination of treacherous lies.

In physics all the misstatements began with the accidental interference of such prominent mathematicians as Poincare, Ritz and some less prominent ones. They simply confused the science of the matter with the purely theoretical formal algebra and geometry. Those were manifestations of young romantic anti-Semitism mixed with delusion. Wilful deceit followed later. Let us read more mature and hard-headed Lorentz, Einstein, Bohr, Heisenberg, Landau and other Gell-Manns. Nothing there but fantasy. They had possibility to dart an unbiased look at the subject using the well-known mechanics and electrodynamics. However, anti-Semitism interfered. So all of them, in their own ways, arrived at the idea to discard the mechanics and electrodynamics when studying the discoveries in the macro- and micro-world, which were numerous at the end of the 19th century and during the whole 20th century. Their ways were different, but the idea was the same: discard the time-tested methods of nature studying. Isn't it stupid? Take a look for yourselves: mechanics, at least, helps us make machines, construct bridges and launch satellites, and electrodynamics introduced television and cell phones to the mankind. This is not the whole picture, this is only a confirmation of their validity and correctness. The most important thing is that they help us study nature and look at it at different angles. They are our new tools, additional to our senses, including eyesight. There's nature, there are binoculars with a telescope, and there are measurement instrumentation, sensors and computers. Look at the world and enjoy it! Yet anti-Semites will not use the new research tools. They don't need mechanics or electrodynamics! Why is that? Are they too clever? Hardly, I'd rather say this is due to a serious lack of intelligence! Take a look for yourselves: discard the tools for the cognition of the

outside world – mechanics and electrodynamics – just as a short-sighted man could discard his glasses – this means a practical implementation of the principle: "the blind person sees better". Is that clever? The absurdity of this principle is obvious not only for the hound from our brochure entitled From Physics to Hypotheses, but also for a cockroach, a snail, and even for a sunflower! Does that mean that anti-Semites are more stupid than cockroaches? Isn't there a reason for doubt? And can you tell me now how we dispel this doubt? Shall we ask a cockroach? Let it use its brains and move its antennae, helping the confused researchers.

Won't the cockroach suspect that the anti-Semites rejecting Averroes and Maimonides had a slight breakdown in their youth and, having bypassed the grown-up phase, went on straight to the senile phase? Or that they are pretending, distracting us to be able to steal.

That is why we say that anti-Semitism is basically either hopelessly stupid, or quite amoral, or rather both. The most important thing is that all of this is extremely dangerous for mankind, as, for instance, physics was ruined by such well-publicized and hard-headed anti-Semites as Lorentz, Einstein, Bohr, Heisenberg, Landau and other Gell-Manns. Economic crises are also stipulated by manipulations with non-matter (finances) to the prejudice of matter (material production). The ones who took advantage of the situation were also very influential opponents of Averroes and Maimonides, that is anti-Semites as well. What should honest people do now?

Let us take a closer look at financial crises. Such events took place in 1929 as well. The alleged reason is that the "accidental" financial collapse resulted in the collapse of the whole economy. Yet, the situation is more complicated. It would be quite appropriate to recall how earlier the anti-Semites in the financial field had consistently destroyed capitalism due to their stupidity and greed. It is well-known that all the advantages of this economic system are freedom and innovation speed. That was the point the anti-Semites attacked. In particular, they made bankrupt of Edison, Westinghouse, Goodrich and other brave inventors and also have eliminated them from innovations and economic decisions to keep others from following their example. Having put responsible professionals and inventors out of the way, anti-Semites put obedient officials in their place. Can a coach, who has never played football, to supervise over successfully a football team? Then comes the collapse. The anti-Semites placed a simple game with conventional objects (money) above material production, or, to be more precise, replaced the latter with it. The only surviving innovator was Ford. But what could Ford do alone? It took Americans dozens of years to recover from the crisis. No analysis followed, no conclusions were made. Even the admissions of the fact that all financial crises are man-made sound uncertain and are extremely rare. Actually also replacement of physics with pseudo-physics was man-made also.

And now there comes another crisis. If someone thinks that the crisis will pass, i.e. the anti-Semites will come to their senses with time, he is under a grave delusion. Can thievish people having less intellect than a cockroach come to one's senses? All they have is grasp reflexes. They call it "monetarism". A recent simple example: the US Government provided financial aid to banks on behalf of the tax-payers, to save the banks from the crisis. \$300 billion from this amount were lost. Where do you think this money is? Do you think they went to the real economy? To the innovators from the real industry, science or engineering? It turns out; the anti-Semites have this money already. They took this money as bonuses for having ruined the whole financial system. Can you feel the logic of the frog or cockroach?

A romantic person might think that that the production volumes will grow by themselves, the US debt will evaporate, and the financial system will recover on its own. These dreams will quickly fall to pieces under the burden of the urgent need for conscious and reasonable actions, which cannot be predicted due to the reasons mentioned above, especially when anti-Semites hold the largest mass media – that's where this half-witted crooks glorify their victory over the clever ones. That is why there is no reasonable feedback.

But why are there so many Jews among anti-Semites? We believe they have been deceived as well. They can hardly like the obvious regress from capitalism to patently anti-Semitic feudalism. And the collection of ridiculous fantasies instead of physics cannot like anybody too.
